## - COURSE DESCRIPTION -

This 2-day training course has been developed by Altitude Training Associates, LLC for the responsible person assigned the role of Stormwater Management Plan (SWMP) Administrator. The course focuses on the qualifications and competencies required of the permit required SWMP Administrator. Day-1 is in the classroom, discussing the requirements for the SWMP Administrator and specific aspects of the SWMP as a functional, guiding set of policies, procedures, practices and strategies. A portion of Day-2 will include a field trip to an active construction site, with participation from a representative of the WQCD, for real life discussions of BMP phasing and how to conduct site evaluations. The course includes a Certification Test. Successful completion of the course includes attendance and a passing the test.

### PREREQUISITE

The Certified SWMP Administrator training program is an intermediate level class. Industry professionals seeking the Certification are required to have completed a basic, 8-hour construction stormwater training program within the past 3-years. Acceptable courses include: the *CDOT Erosion Control Supervisor Certification*, *Stormwater Management and Erosion Control During Construction (SMEC)*, *SMEC for Oil & Gas Operations* or *BMP 101: Storm Water Management During Construction-Montana*.



**Certifications are valid for 3-years. To maintain an active Certification, Recertification will need to be completed prior to expiration.**
